- 3.3. We may also use information in aggregate form (so that no individual user is identified) to:
 - a. build up marketing profiles
 - b. aid strategic development;
 - c. manage our relationship with advertisers; and
 - d. audit usage of the Site.
- 3.4. We may disclose your personal information to third parties where:
 - a. we have your consent;
 - **b.** we use third parties to assist us in providing services and you have elected to receive one of those services. The third party would only be permitted to use your information for the purposes of providing that service to you; or
 - **c.** we are compelled by law or a court order to do so, or if we believe that such action is necessary for the purposes of the legitimate interest pursued by EOH, to protect and defend the rights, property or safety of EOH, the Site, visitors to the Site or others.
